On Wednesday, May 5th, the TIA Policy Committee met for the first time with the goal and intention of increasing awareness of the Association on Capitol Hill, being a unified source for decision-makers, raising awareness of the industry and increase value for members and implant a cohesive policy strategy that reaches across all sizes of TIA Members.

The Committee outlined several initiatives to begin work on, including:

On May 11th, the House Transportation & Infrastructure Committee Chairman Peter DeFazio (D-4th/OR) will be providing a keynote address to the roughly 400 attendees at the 2021 TIA Annual Conference being delivered virtually. Chairman DeFazio will be speaking about President Biden's plan for addressing our nation's infrastructure challenges and Congress' role in developing a Surface Transportation Reauthorizatrion Bill, with the FAST Act set to expire again on September 30, 2021.

President Biden's American Jobs Plan is a \$2.2 trillion package focused on physical infrastructure needs and projects, as well as goals favored by his Administration. This will be a tremendous lift for the Administration and Chairman DeFazio will be on the forefront working to achieve this goal and pass the American Jobs Plan.

## IC Rules Finally Withdrawn

With no surprise to anyone following the regulatory events of the last six months, the Biden Administration has pulled the plug on a major Trump initiative. Last week the Wages and Hours Division of the Department of Labor withdrew the Independent Contractor Rule that was started under President Trump and delayed under President Biden. The Department did not indicate how they would move forward with millions of independent contractors (IC). This move is almost a nod to Congressional Democrats to move forward with their prized "PRO Act." This bill is a litany of bad ideas jammed packed into a piece of legislation that has a slim chance of making to the president's desk as the procedural rules remain its only barrier. Only three Senators are the current hold outs that is keeping the Senate from voting on this legislation. The pressure is mounting for Senate Democrats to pass the bill, by any means necessary.

TIA has met with all three members of the Senate who have not publicly supported the legislation. Additionally, the 9th circuit has recently ruled that there is no exception for motor carriers under the ABC test of A.B. 5, the draconian bill from California which forces employee status and places the burden for proving IC status on individuals' workers. This sets up a Supreme Court fight in the near future to determine the strength of the separation between employee and IC status.

TIA is strongly in opposition to the PRO Act and has acted accordingly. While being mindful of current legislative priorities, we have continued our outreach to ensure our members voice is heard on this issue.

## MCSSS: Problem Solvers Caucus

TIA Government Affairs sees a path forward on our Carrier Selection legislation through a powerful House Caucus known as the Problem Solvers Caucus. This bi-partisan group of Congressmen and women are some of the most action oriented sitting Members of Congress. This path forward became apparent last Congress when Rep. Josh Gottheimer (D-NJ) co-sponsored our legislation. Here is what needs to happen: First we need a Republican and Democrat to sponsor the bill internally, within the caucus. Next, we need 70% of caucus members or more to support the legislation. If we can complete these action items, this legislation will garner more support and have a higher percent chance of passage.

The Committee vote for this legislation is expected around May 25th, so we hope to have a formal endorsement by that time. These processes are very fluid, so we continue to be monitoring multiple avenues for a path forward on this bill.

Motor carrier selection legislation continues to be our top priority bill. TIA will seek its passage through the traditional amendment and markup process in addition to our Problem Solvers Caucus route.
