

House Rules Committee Derails MCSSS Amendment

Last week, the House Rules Committee met to discuss the "rules" of the debate on H.R. 3684, the INVEST Act of 2021 or the Surface Transportation Re-Authorization Bill on the House floor. One of the more than 200 amendments that were filed includes Amendment #185 offered by Congressmen Moulton (D-MA), Phillips (D-MN), Gallagher (R-WI), and Stauber (R-MN), which would implement an interim Motor Carrier Selection Standard (MCSSS) in two years if the FMCSA fails to implement a new motor carrier safety rating system. This amendment was a further compromise from the TIA-supported H.R. 3042 which placed the interim standard in place until the rulemaking was completed.

TIA and our members have been working overtime the last month or so on this compromise and gaining as many supporters as possible. Our efforts paid off, but also cost us a chance to have this amendment considered on the House floor.

The Rules Committee ruled the amendment not in order, which is surprising as it had bi-partisan support and was certainly germane to the INVEST Act. Based on the information we received from the Committee, we were too close to passing this on the House floor that Speaker Pelosi and the Trial Bar was nervous and could not take a chance at this getting a vote. We are not giving up the fight on this issue and will continue to build a strong coalition to get this MCSSS into law.
